- CSARTS-SGV routinely solicits input from parents, students, staff members, and community groups to provide data and inform decision making at the school. During the 2021 school year cycle to solicit input from the community the following groups helped to contribute input for the Expanded Learning Opportunities Grant:
- Parents - With the timing of the annual collection on WASC data, parent feedback was also harvested for the purpose of informing decisions on ELO funding recommendations as well as parent surveys throughout the year helped to identify patterns of responses on student needs
- Teachers – teacher feedback for plan development was facilitated by focused groups, curriculum leads from their curriculum team members, individual conversations with administrators, and survey data
- School Staff – school administration reviewed learning priorities, and solicited feedback in department meetings in order to help develop the plan
- Community partners- SELPA, local school district, and sister campus administration helped inform our practices.

Consistent feedback from stakeholder groups indicated a desire to address academic and artistic skill gaps, provide opportunities for credit recovery, support students with technology needs, help teachers with instructional delivery models, address social/emotional supports for all students, especially students with disabilities. Additionally, the CSARTS-SGV community expressed a deep commitment and need to return to full in-person learning and maintain that instructional model.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
